Call to Order

President Ono called the meeting to order at 3:31pm.

Senate Membership

NEW MEMBER

The Registrar welcomed Ms Kelsey DesRoches, Student Representative At-Large, to fill a vacancy until 31 March 2018 and thereafter until replaced.

The Registrar issued a renewed call for two (2) students to serve on the Senate Nominating Committee. Nominations were due 15 September 2017.

Business Arising from the Minutes

The Acting Secretary drew Senate's attention to the recent correspondence received by many senators from Senator Wylie regarding points of order and his own reply that was copied to the Senate for its information.

Remarks from the Chair

The President announced the appointment of Dr Andrew Szeri as Provost and Vice-President Academic for the Vancouver campus effective 1 July 2017. We're pleased to have identified a leading candidate from a strong pool of candidates.

Secondly, Dr Ono noted that a search was being undertaken for a Vice-President Research & Innovation. He hoped that the present list of 7- semi-finalists would be narrowed down shortly and that a candidate would accept in time for the next academic year.

Thirdly, Dr Ono reminded Senate that Lisa Castle has announced her resignation as Vice-President, Human Resources, and a search committee is being formed to find her successor by the next calendar year.

Dr Ono stated that the first phase of the strategic plan development – engagement – has been completed. Around 7500 submissions, some very detailed, were made to the University, which have been grouped into 8 potential areas of focus. The day prior to this meeting of Senate, an executive and decanal retreat was held, and task forces are being formed to focus on focus areas to meet over the summer. The President committed to bringing that work back to the Senate in the fall.

The President advised Senate of his recent travels to Asia and the signing of a trilateral agreement of cooperation between UBC, the University of Tokyo, and the Max Planck Society of Germany.

Finally, Dr Ono advised that the American Academy of Arts & Sciences has extended an invitation to UBC to be an institutional affiliate. The President characterized this as a significant invitation given their highly developed program in the humanities and sciences.

Remarks from the Deputy Vice-Chancellor

Dr Deborah Buszard informed Senate of Bryce Traister having been appointed as Dean of the Faculty of Creative & Critical Studies. She expressed her thanks to Robert Eggleston for serving as Acting Dean of the Faculty for the past two years.

The Deputy Vice-Chancellor noted the successful Teaching & Learning conference and awards ceremony on the Okanagan campus.

Senator Keyes suggested that a joint meeting with the President and Vancouver would likely be the most productive use of time.

Dr Sadiq replied that they were trying to establish the same structure as Vancouver. It will be a very small program and will join the existing grauated programs and staff in the School without significant additional expense.

With permission of Senate Dr Abbas Milani also spoke, nothing the appetite and encouragement to create a national role model for such an institute within Applied Science

A student senator noted that the Library had a gap identified in its collection and asked if this would be filled.

Dr Barker replied that the pricing for the material had become unreasonable and many universities were trying to address this issue.

The President noted the onerous inflationary increases on materials in recent years.

Dr Legault explained that most of the proposed changes were editorial in nature; however, one moved the criminal record check to admission requirements from the program requirements; another adjusts the language proficiency test score to be slightly higher than those basic ones for the College of Graduate Studies.

A senator asked for a rationale for the English language requirement being made stricter.

With the permission of Senate, the Director of Social Work advised that their program focused on clinical environment was different from most others and client understanding was important in that field. Thus, a greater ability to communicate in the English language was required.

Senator Evans asked if all programs were currently in compliance with the existing policy.

Senator Legault replied that the Faculty of Management was currently not in compliance.

Senator Lalonde asked how "comparable" would be assessed between domestic and international students.

Dr Lasserre said that a sub-committee was being established to determine what comparable means and to ensure we are in compliance.

With permission of Senate, Mr Andrew Arida, Associate Registrar for Undergraduate Admissions, spoke, saying that they tried to equate grades across school system to achieve targets.

ANNUAL REPORT

Dr Legault brought Senate's attention to the three areas under which the Senate Admissions & Awards Committee had acted under delegated authority from Senate:

APPEALS ON APPLICATIONS FOR ADMISSION, READMISSION AND TRANSFER TO PROGRAMS

Pursuant to section 37(1) (b) of the *University Act*, the Okanagan Senate has delegated to the Admissions and Awards Committee the authority to hear final appeals on applications for admission and readmission to the University. In compliance with the *Rules and Procedures of the Okanagan Senate*, the Committee herein reports on its decisions.

Between May 1, 2016 and April 30, 2017, the Admissions and Awards Committee heard 17 student appeals for admission to a degree program (compared to 18 in 2015/16, 11 in 2014/15, 12 in 2013/14, 13 in 2012/13, 14 in 2011/12 and 17 in 2010/11). Appeals can be allowed (and the applicant admitted) or dismissed. Of the appeals heard by the Committee, 5 were allowed and 12 were dismissed.

NON-SUBSTANTIVE OR EDITORIAL CHANGES TO EXISTING ADMISSION REQUIREMENTS

In January 2016, Senate delegated to the Committee final right of approval over non-substantive and editorial changes to existing admission requirements. From May 1, 2016 until April 30, 2017 the Admissions and Awards Committee has approved no proposals under delegated authority.

STUDENT MOBILITY AGREEMENTS APPROVED UNDER COUNCIL OF SENATES POLICY C-2: *AFFILIATIONS WITH OTHER INSTITUTIONS OF LEARNING*

Under Policy C-2: *Affiliations with Other Institutions of Learning*, the Council of Senates has delegated to the Admissions and Awards Committee the authority to approve on its behalf, terms of student mobility agreements for students going to or coming from UBC Okanagan programs. In 2016-2017, the Admissions and Awards Committee has approved student mobility agreements with the following institutions:

Senator Campbell asked for the rationale for this change.

Senator Keyes said that they received a suggestion from the Provost for this change as a way of ensuring renewal and mobility.

Senator Lalonde noted that chair recruitment was already an issue.

Senator Mathieson said that if succession planning was a problem, we needed to ensure that people find these leadership opportunities are open and attractive to people.

Senator Campbell said that he was in favour of a succession process but this would be the only position on Senate that is term limited. This would be a rule that impacts upon only one senator on that time. He noted that having been pressed into service in the past and that there was not

often demand to some chairships. He further suggested that experience is needed in some roles that would be lost if this proposal was approved. .

Dean Tettey said that at the Nominating Committee was trying to find a balance between experience and infusing committees with fresh ideas and creating opportunities. Positions being tied to people for too long creates a disincentive for people to get involved.

Senator Berg noted that he was leaving Senate because he didn't have any opportunities on committees that interested him.

Principal Buszard noted that leadership roles on campus all have terms and this is considered important for renewal and progression.

Senator S. Lawrence suggested that this rule change could be liberating. People become associated with positions at some place. No one else has institutional memory.

Senator Legault noted that she became a committee chair six months after joining the committee due to health issues for the previous chair.

Senator Vinek spoke in favour of the change so long as there was appropriate support and guidance for chairs.

Senator McNeil asked if it would apply retroactively.

The Acting Secretary advised that past service would count for next triennium.

Following a referral made at the April 27th, 2017 meeting of the Okanagan Senate, the attached motion was considered by the Senate Academic Policy Committee. The Academic Policy Committee met to discuss this matter on May 2nd, May 25th, and June 21st of 2017. To support its discussions, the Committee also reviewed the minutes of the Okanagan Faculty of Education Faculty Council meetings from the departure of Dean Lynn Bosetti in January 2014 to the appointment of Dean Blye Frank in January 2017. The Committee is thankful to the Faculty of Education for quickly and fully responding to this request so that we were able to have this information for our June meeting.

Upon review of the submitted motion, the Committee identified the following issues. With regard to each of the issues set out below, the Committee was able to reach a consensus in their opinion, a summary of which is provided.

Issue 1: Whether the establishment of a Senate Ad Hoc Committee would be appropriate for the consideration of the matters referenced in the motion.

The Academic Policy Committee consulted its Terms of Reference, which state that it is responsible for:

- Significant matters of academic policy and general academic regulations, if such matters are not explicitly covered by the terms of reference of another committee of Senate; and
- Proposals for the organization or re-organization of academic units.

Given that the matters concerned within the motion are within the purview of the Academic Policy Committee, the Committee felt in unnecessary to convene a Senate Ad Hoc Committee for this purpose.

Issue 2: Whether proper procedure for consultation and approval with Senate and its standing committees had been followed with regard to plans for the possible reorganization of the Faculty of Education.

The Senate and its Committees are not generally involved in proposals while they are still being developed at the Faculty level. The Committee understands that the details of any plans for the reorganization of the Faculty are still in development, and that a proposal will be forthcoming in the 2017/18 academic year. Therefore, at this time the Committee believes that further involvement of Senate and its Committees before the faculty has developed a recommendation would be premature.



Issue 3: Whether any infringement of Joint Senate and Board Policy #21 – Appointment of Deans and Principals, or Board Policies #22 and #23-Extension of Appointments of Deans had taken place.

Upon review of the policies in question, the Committee determined that the key issue in question is the fact that the Faculty of Education has had acting/interim Deans in place for over 24 months, whether this is incompliance with section 4.1 of Policy 23 as set our below:

4.1. Notwithstanding anything else in this Policy or anything in Policy #21, the President may designate in writing that an individual, including the incumbent, take on the role of Dean in a pro tem capacity where the incumbent's appointment has ended and a successor has not yet taken office; provided however, that:

4.1.1. any such designation normally shall not be for a period of more than 12 months; and

4.1.2. if successive designations are made, the aggregate length of the designations normally shall not exceed 24 months.

The Committee noted that the presence of the word "normally" in both subsections 4.1.1 and 4.1.2 may allow for the length of any temporary appointment to be longer than 12 months, and for successive temporary designations to exceed 24 months, should circumstances warrant.

Issue 4: Whether the circumstances during this period were sufficiently extraordinary to justify departure from the usual practice outlined in Policy as per the above.

The Committee believes that circumstances were unusual enough to meet this test. Normal circumstances would preclude there being conversations occurring about possible reorganization of the Faculty. Furthermore, the Bachelor of Education program was undergoing significant curriculum renewal that was also taking place during the period in question. The Committee concurs with the Provost that recruiting a new Dean under such circumstances would be neither prudent nor strategic.

In summary, the Senate Academic Policy Committee has determined that the acting and *pro tem*. appointments of Deans Binsted and Frank were appropriate and did not infringe upon the policies in question. The Committee looks forward to reviewing the detailed proposal setting out plans for the future of the Faculty of Education when it is submitted in due course.



Whereas:

- 1. UBCO Faculty of Education is a Faculty of UBC Okanagan campus, so constituted under the University Act;
- 2. It has been without a Dean since February 2014, over 3 years, in violation of Policies 21 and 23, and a series of Acting Deans have been appointed by University administrators;
- 3. It has had Head/Directors appointed by University administrators to look after Collective Agreement matters such as workload, tenure and promotion in the Faculty since 2014 without the administration following Policy 22 on the appointment of such Head/Directors;
- 4. Senate is the body with the power under the University Act to recommend to the Board the discontinuance of a Faculty;
- 5. University administrators have told the Faculty that it can no longer continue as a Faculty;
- 6. Discussions are in an advanced stage between administrators in Vancouver and the Okanagan with regard to the Faculty being discontinued and reconfigured as an Institute under the administration of the UBC Vancouver Faculty of Education;
- 7. To date, Senate or any of its Standing Committees has yet to be consulted on the possible discontinuance of the Faculty.

Be it so moved that:

Senate constitute an ad hoc committee to consider and report on these violations of Policies 21, 22 and 23 and recommend a process of consultation with Senate regarding discussion of options and alternatives that may or may not include a possible discontinuance of the Faculty of Education and/or processes regarding the appointment of a Dean and a Head/Director in keeping with Policies 21, 22 and

23. In the alternate, that the matters be referred to the Academic Policy Committee and/or any other relevant Senate committees for recommended actions.

Re:	Admissions Proposal – Revisions to the English Language Proficiency Tests and Programs

The Committee has reviewed and recommends to Senate for approval revisions to the list of acceptable English Language Proficiency Tests and Programs to meet undergraduate admission requirements.

All UBC applicants must satisfy English Language proficiency. Attendance at an Englishlanguage Canadian secondary school satisfies this requirement while other applicants are required to complete some form of English language proficiency testing to indicate their proficiency level. UBC accepts a selection of tests to satisfy the admissions requirement; the most common tests are IELTS and TOEFL.

As the Canadian English Language Proficiency Index Program (CELPIP) is no longer offered, CELPIP should no longer be accepted and should be removed from list of accepted tests. Additionally, the Canadian Academic English Language assessment (CAEL) now offers a computer-based option. This option should be added to the list of accepted proficiency tests and the computer-based threshold should be aligned with the CAEL paper-based option threshold. Although CAEL is not a widely-used test, Undergraduate Admissions will be monitoring the performance of students accepted with the computer-based option to ensure the thresholds are set appropriately.

The following is recommended to Senate:

Motion: That Senate approve changes to English Language admission standards for undergraduate applicants to the University, effective for admission to the 2018 Winter Session and thereafter.

Rationale:

The CELPIP – Academic English test is no longer being offered. The last valid tests that have been written have expired so we are now removing reference to it on our Calendar page.

The CAEL test now has a new version. The Computer Edition of the test has some improvements but the fundamental content and scoring methodology remains unchanged. Much of this is described in the documents provided but this change is to signal the adoption of this new version of the test.

The score recommendation is being provided by Paragon Testing at the moment but since they recommend the same score for both the previously offered paper-based test and the new computer edition, the Undergraduate Admissions Office feels that it would be appropriate to accept this recommendation, but to review the performance of these test presenters to see if any edits to the score cutoffs are required. Please note that at this time, CAEL is not a very common test that is presented to satisfy our English Language Admission Standard.
