Call to Order

Vice-Chair Dr. Owram called the Senate to order.

Approval of Agenda

The agenda was approved by consent.

Senate Membership

Secretary Mr. Brian Silzer welcomed the new and returning Student Senators serving a one-year term from 01 April 2008 to 31 March 2009. Four new Joint Faculties Members with a term-ending on 31 August 2008 were also made welcome. One vacancy for a student representative for the Faculty of Education was declared.

Minutes of the Previous Meeting, 12 March 2008

Moved: Mr. Koovisk Seconded: Dr. Gustar

That the minutes of the Okanagan Senate Meeting of 12 March 2008 be adopted as circulated.

CARRIED.

Vice-Chair's Remarks and Related Questions

Vice-Chair Dr. Owram noted the meeting regrets of President Toope.

The Vice-Chair noted the following highlights:

- All Okanagan Senate recommendations of 10 October 2007, 07 November 2007, 16 January 2008, and 13 February 2008 had been approved by the Board of Governors.
- On 16 April, Deputy Vice-Chancellor Dr. Owram and Okanagan Senator Dr. Cioe would attend the Vancouver Senate meeting to discuss aspects of the overall UBC system from an Okanagan campus perspective.
- An April meeting to discuss the 2008 UBC Okanagan Budget would be organized between the Council of Senates Okanagan Budget Sub-Committee and the Deputy Vice-Chancellor's Office. The Vice-Chair noted that the overall \$4.5 million cut to UBC Okanagan's incremental budget is correct. He added that a 2.6% reduction across the board to all BC colleges and universities had been announced in April by the Ministry of Advanced Education. This reduction will likely slow UBC Okanagan's growth rate although Dr. Owram confirmed that operations would continue without the need to close programs or schools. Further, the hiring freeze has been removed and hiring new faculty will move forward as anticipated.
- Vice-Chair Dr. Owram, although admittedly taken aback by the provincial budget processes, remained hopeful, in part due to the continued support of the Okanagan campus from regional and provincial communities.

Discussion

Dr. Cioe reiterated a media comment, asking whether the Deputy Vice-Chancellor's Office could confirm whether UBC Okanagan's growth target would remain as initially announced by the Government. In response to Dr. Cioe, Vice-Chair Dr. Owram noted that

it was still too early to report enrolment figures. However, he suggested that the enrolment vision to enroll 7,500 students would remain unchanged.

Mr. Lepp inquired to whether cuts to the 2008/2009 Budget would influence the plans for the new Faculty of Management and the School of Engineering building. Vice-Chair Dr. Owram confirmed that the new building would proceed.

In response to a query from Dr. Keyes, Vice-Chair Dr. Owram noted that a budget update would be presented to the Board of Governors on 10 April 2008. The final budget would be submitted to the Board at its June 2008 meeting.

Dr. Williams asked about the status of the Strategic Planning Initiative (SPI). In light of the budget, Vice-Chair Dr. Owram confirmed that the SPI would likely be on hold until the fall.

A few Senators discussed the paving status of the temporary parking lot, located behind the future Student Union Building. Vice-Chair Dr. Owram indicated that he would investigate any plans for paving in that area.

Nominating Committee - Dr. Robert Lalonde

Senate Committee Assignments

The Committee Chair Dr. Robert Lalonde recommended the following motions to Senate.

Moved: Dr. Lalonde Seconded: Dr. Cioe

That Dr. Gordon Binsted be appointed to the Committee of Appeals of Standing and Discipline as Faculty Representative until 31 August 2008 and thereafter until replaced.

AND

That Dr. Carolyn Labun be appointed to the Committee of Appeals of Standing and Discipline as Faculty Representative until August 2008 and thereafter until replaced.

AND

That Dr. James Johnson be appointed to the President's Advisory Committee for the Selection of the Registrar.

AND

That Dr. Jennifer Gustar be appointed to the President's Advisory Committee for the Selection of the University Librarian.

AND

That Dr. Gordon Lovegrove be appointed to the Council of Senates Budget Committee until 31 August 2008 and thereafter until replaced.

CARRIED.

Policies & Procedures Committee – Dr. Daniel Keves

The Committee Chair Dr. Daniel Keyes presented the report.

Granting of Graduate Degrees

The Committee had circulated a proposal to approve an interim arrangement for the granting of graduate degrees. The group of candidates expected to graduate in June 2008 include the degrees of Master of Arts in Education, Master of Arts in Interdisciplinary Graduate Studies, Master of Education, Master of Fine Arts in Interdisciplinary Graduate Studies, Master of Science in Interdisciplinary Graduate Studies, Master of Science, Master of Nursing, and Master of Social Work. The Committee recommended that as the faculties of Arts and Sciences, Creative & Critical Studies, Education, and Health & Social Development have each delegated to the College of Graduate Studies the responsibility of recommending candidates to the Senate for the granting of their respective graduate degrees at its May 2008 meeting, the name of the College shall appear as the recommending body on corresponding degree parchments and the Dean of the College shall sign such parchments in addition to the Chancellor, President and Registrar.

Moved: Dr. Keyes

Seconded: Dr. Abd-El-Aziz

That the Senate approve the interim arrangement for the granting of graduate degrees in May 2008, as recommended by the Policies & Procedures Committee.

CARRIED.

Curriculum Committee

The Committee Chair Dr. Jennifer Gustar presented the report from the Faculties of Arts and Sciences, and Creative and Critical Studies.

That Senate approve the new courses brought forward by the Faculties of Arts and Sciences as set out in the attached proposals.

Moved: Dr. Gustar Seconded: Dr. Cioe

Discussion

A friendly amendment, offered by Dr. Cioe to edit the spelling of the word 'behavior' as proposed in the new course title, PSYO 442: Interpersonal Behaviour and Psychopathology, was accepted.

The motion was put and carried.

Dr. Gustar asked that the new course JPST 420 and CULT 420: Gaming Theories, Methodologies, "Japaneseness" – cross-list, be withdrawn from consideration by the Senate at this time

That Senate approve the new courses brought forward by the Faculties of Creative and Critical Studies as set out in the attached proposals.

Moved: Dr. Gustar Seconded: Dr. Williams

Discussion

In response to a question from Ms. L'Orsa, Dr. Gustar noted that proposed new course FREN 299: French Literature in Translation would be taught in English. Dr. Williams asked whether FREN 299 could then be counted for credit toward a major in English. Dr. Gustar informed Dr. Williams that the Senate Curriculum Committee would likely discuss this item at its next committee meeting. Mr. Dobson asked whether FREN 299 should then be proposed as an English course, rather than as a French course. Dr. Gustar stated that although the course is English language-based, French Literature is the primary focus of the course and expressed the opinion that its FREN subject code was appropriate. She added that the proposed new course would not apply to a minor or major in language.

In response to a Senator's opposition to cross-listed courses, Dr. Gustar commented that cross-listing arrangements have been working successfully in the Faculty of Creative and Critical Studies. She added that the Faculty has found that, by combining various levels of expertise and disciplines related to literature, English, cultural studies, and others, cross-listed courses are effective in cases such as minor and major degrees. Dr. Wrzesniewski asked whether cross-listed courses would be counted twice for credit. Dr. Gustar stated that the cross-listed special topics courses are differentiated from one another with a letter; therefore they cannot be counted twice unless the material is substantively different from course to course. In response to a question from Dr. Labun, Mr. Eaton confirmed that should cross-listed courses diverge, then one of the two courses would become a new course, while the other would remain as a special topics course.

Dr. Ungureanu asked about the stylistics aspect of the proposed FREN 453 *Advanced Syntax and Stylistics*; she noted that there is no mention of stylistics in the course description, which could be misleading to students considering FREN 453. She was invited by Dr. Gustar to refer additional queries to the French program in the Faculty of Creative and Critical Studies.

The motion was put and carried.

Admissions and Awards Committee

The Committee Chair Dr. Sharon McCoubrey presented the reports:

New Award

Moved: Dr. McCoubrey Seconded: Mr. Koovisk That the Senate accept the new award as listed and forward it to the Board of Governors for approval, and that a letter of thanks be sent to the donors.

UBC Okanagan International Community Achievement Award

Three awards of \$3,000 each are offered by the International Student Initiative to continuing international students at The University of British Columbia Okanagan who have demonstrated leadership in one or more of the following areas: community service, cross-cultural relations, promotion of diversity, intellectual pursuits, and artistic or athletic endeavours. The award is made on the recommendation of Student Development in consultation with the International Student Initiative and Faculties at The University of British Columbia Okanagan. (First awards available for the 2008/09 Winter Session)

Discussion

In response to a question from the Senate, Dr. McCoubrey confirmed that only undergraduate students would be eligible for the proposed new award.

The motion was put and carried.

Provincial Examinations Calendar Entry

The Committee had proposed a Calendar entry reflecting the recent Senate decision to change UBC Okanagan admission requirements to discontinue the requirement for final BC Provincial Examinations for admission to UBC Okanagan.

Moved: Dr. McCoubrey

Seconded: Dr. Cioe

That the Senate accept the provincial examinations Calendar entry as set out in the attached proposal.

CARRIED.

Academic Leave Policy

The Committee had proposed Calendar entry on academic leave from any UBC Okanagan undergraduate program.

Moved: Dr. McCoubrey

Seconded: Dr. Cioe

That the Senate accept the academic leave policy as set out in the attached proposal.

Discussion

Mr. Silzer responded to a question by stating that, the measure of good standing, as noted in the calendar entry, would be specified by each program. In addition, he confirmed that students returning to their programs following an academic leave would be required to meet the academic regulations and program requirements in effect at the time of admission, although the returning student would not be required to meet new admission requirements.

The motion was put and carried.

Mature Student Policy

The Committee had circulated a proposal to revise the definition of Mature Students in the Calendar entry entitled Classification of Students.

Moved: Dr. McCoubrey Seconded: Dr. Labun

That the Senate accept the mature student policy as set out in the attached proposal.

Discussion

Several Senators expressed concerns that the proposed mature students' classification focused heavily on "achieved excellence", which could exclude some potential students' entry to UBC Okanagan. Mr. Silzer stated that the proposed mature student policy should broaden the access point for students and would provide another avenue to UBC other than through Access Studies. He confirmed that each mature student applying for admission to UBC Okanagan would be considered individually.

Dr. McFadyen spoke in favour of the motion, noting that the Faculty Dean would consider the likelihood of the student's success prior to admitting them. Dr. Gustar, noting her support of the overall principle of the proposal, stated that she would prefer to adopt a variation of the outlined processes included in the proposal.

In response to further comments and recommendations from the Senate Mr. Silzer noted that Enrolment Services would take them under advisement. He suggested that Senators draft a separate proposal related to the processing of Mature Student Applications at some point could be prepared and circulated to the Senate in future.

The motion was put and carried. Three opposed.

Learning and Research Committee

UBC Okanagan Scheduling Guidelines

The Committee had circulated a proposal to endorse the UBC Okanagan Scheduling Guidelines. The policy had been brought to Senate on 16 February 2008 and was referred back to the Learning and Research Committee for further consultation. That consultation had been completed. The Committee Chair Mr. Arthur noted that, the most recent draft of

the guidelines benefited from the additional consultation, which has been incorporated into the proposal.

To differentiate between an item being approved or endorsed, the Vice-Chair looked to Ms. Collins. She noted that, the Senate shows their support for an item through endorsement, which applies generally to guidelines. Principles however would be approved, as is the case with the following motion related to UBC Okanagan Scheduling Principles. Vice-Chair Dr. Owram reminded Senators that finding a balance between 'processes and principles' remains a challenge.

Moved: Mr. Arthur Seconded: Mr. Koovisk

That Senate endorse the Scheduling Guidelines for UBC Okanagan as presented by the Learning & Research Committee.

Discussion

In response to Dr. Lalonde, Mr. Vogt confirmed that the afternoon sessions as shown in the proposal are scheduled based on 1.5 hour standard timetable blocks.

Dean Bottorff acknowledged that #8 of the current Scheduling Guidelines as enclosed has been problematic to the new Faculty of Health and Social Development programs. She requested that given strong instructor preferences in her Faculty, fewer one-hour blocks be utilized. To date, the Faculty had chosen to schedule three-hour evening classes, rather than accept one-hour blocks. Dean Bottorff stated that therefore she could not support the 40% of one-hour blocks as recommended in the Guidelines. Mr. Vogt verified that the results of several faculty surveys showed that, 70% of faculty members preferred the one-hour blocks.

"8. For lecture sessions held between 9:30 am and 2:00 pm, faculties normally schedule 40% in one-hour blocks and 60% in 90-minute blocks. The Dean and/or Provost are consulted on any variance of this distribution,"

Dr. Reid noted that the limitation of the scheduling guidelines seems to be the lack of classroom space, which therefore impacts how class time is organized. Mr. Silzer confirmed that, classes are scheduled to balance the optimization of building space while servicing the need of students to fulfill their program requirements. He added that, without infinite resources, any adopted scheduling model would have some impact on individual circumstances. The scheduling guidelines are designed to accommodate the most people that we can within the system. Vice-Chair Dr. Owram added that the administrative side of the class scheduling activity must also be considered. Dr. Cioe expressed the opinion that the Senate could choose the appropriate level of detail for its consideration of the scheduling guidelines.

In response to a question from Dr. Duran-Cogan, Vice-Chair Dr. Owram confirmed that, UBC does not have a faculty attendance policy.

The motion was put and carried. Two opposed.

Policies and Procedures Committee

UBC Okanagan Scheduling Principles

Dr. Keyes introduced the report by stating that, the work of the Learning and Research Committee is to develop sound policies and procedures related to the area of Scheduling Guidelines a policy gap had been observed. Therefore, the Committee Chair proposed the following amended motion.

Moved: Dr. Keyes Seconded: Dr. Broughton

That Senate direct the Learning and Research Committee to prepare for Senate's consideration no later than December 2008 a policy setting out principles for <u>course scheduling and</u> mechanisms to establish or amend scheduling guidelines at UBC Okanagan

CARRIED.

Ad Hoc Committee to Consider the Format of the UBC Okanagan Convocation Ceremonies

Dr. Reid asked that the text 'if feasible' be struck from item e. as noted below. The Committee also requested that it be discharged.

The Committee presented the following report for information:

Senators may recall that in March 2008 the Senate established an Ad Hoc Committee to Consider the Format of the UBC Okanagan Convocation Ceremonies. The Ad Hoc committee was delegated Senate authority to make decisions with respect to the format of the June 2008 Okanagan graduation ceremonies.

- a. **Emeriti**: The current practice of inviting professors emeriti to attend Convocation will continue.
- b. **Faculty Participation**: In an effort to increase faculty participation, UBC Okanagan faculty members will be invited to participate in Convocation by printed invitation, followed by a reminder by e-mail.
- c. Welcome Walk and Exit Applause: That the Ceremonies Office would coordinate, through the graduation marshals, the 'welcome walk' to include all faculty members and other members of the UBC Okanagan community, as the student graduates advance from the central courtyard to the graduation ceremonies held in the gymnasium. A similar 'applause guard' will be present as the students exit the graduation ceremonies and advance towards the courtyard;

- d. **Enhanced Music**: A fuller, regional musical experience inside the gymnasium will be coordinated by the Ceremonies Office, so as to improve the overall experience for guests attending the graduation ceremonies.
- e. **Bagpipes**: If feasible, Bagpipes will be included to lead the student and faculty processions from the courtyard to the gymnasium for the graduation ceremonies. In the event that a bagpiper is not available, the Ceremonies Office will coordinate, with Senate approval, an equally evocative musical choice.

Discussion

Dr. Cioe expressed concern that professional development funds cannot be utilized to purchase graduation gowns. In an effort to increase faculty participation, he encouraged the Learning and Research Committee to consider the authorization of professional development funds to be used in this manner. Dr. Cioe congratulated the ad hoc committee on their work. Dr. Williams suggested that the faculties might rent generic graduation gowns for their faculty members. Vice-Chair Dr. Owram noted that this matter would be considered.

Dean Belton reminded Senators that sustainability is a pillar of the university and that encouraging print invitations does not support this. Dr. Reid noted that the Committee is maintaining a current practice of mailing invitations to faculty members. Vice-Chair Dr. Owram asked that all Deans remind their faculty members to attend the graduation ceremonies.

In response to an additional question from Dean Belton, Dr. Reid noted that the Okanagan region holds much musical talent that should be utilized for the graduation ceremony. He added enhancements to the music would improve the convocation experience for all participants.

Moved: Mr. Koovisk Seconded: Dr. Lalonde

That the Senate thank and discharge the Ad Hoc Committee to Consider the Format of the UBC Okanagan Convocation Ceremonies.

CARRIED.

Report from the University Librarian –Ms. Melody Burton, Head, UBC Okanagan Library

Ms. Burton had circulated a link to the electronic version of the 2006/2007 Report of the University Librarian to the Senate, which was available at: www.library.ubc.ca/home/UBC RS 2006-07 fa.pdf.

Themes from the 2006/2007 year for the Okanagan Library included the following:

- The continued growth of the distinctly different UBC Okanagan branch within the unified UBC Library system.
- The electronic resources are now as significant as the tally of book resources. Whether in print or electronic, the most critical contribution the Library makes is to the student learning and faculty research.
- The ability for the Okanagan Library to purchase new monographs almost 10,000 last year. A significant \$20,000 gift from Kenneth Whittall allowed for the purchase of mathematics monographs.
- The contribution of numerous e-resources to the UBC Library system including: ARTSTOR, Emerald, Backfiles, Ageline, and American Film Institute catalog.
- Although the Okanagan Library is currently limited by physical space, the planned opening of the south wing of the Irving K. Barber Learning Centre in Vancouver is an exciting venture that combines learning spaces, a traditional study hall, and more, to be the only one of its kind in Canada.

Discussion

In the spirit of collaboration, Dr. Keyes asked whether a Western Canadian consortium-type arrangement with the University of Alberta has been considered. Ms. Burton confirmed that the universities already collaborate by negotiating collectively with national vendors when purchasing new materials for the Library.

In response to from Dr. Williams, Ms. Burton stated that a survey related to library space at the Okanagan campus has been recently circulated. The results of a survey circulated last year showed that, the university community requires additional space and longer library hours during peak periods. Ms. Burton is hopeful that additional study and collection space would be available in the longer term. Vice-Chair Dr. Owram noted that once the campus has sufficient classroom space, then the Library could expand to the second and third floors of the Library building.

Adjournment

There being no further business, the meeting was adjourned.

The following regular meeting of the Senate was scheduled to be held on Thursday 15 May 2008 at 3:30 pm to 5:30 pm in Library 317.

Proposed Changes to Chancellor Selection Process

As Senate may be aware, our provincial government has introduced Bill 34, The University Amendment Act and scheduled it for second reading (May 1, 2008).

The provision that affects UBC relates to the selection of the Chancellor. Bill 34 proposes to amend the University Act such that the Chancellor will no longer be elected by and from the Convocation, but rather he/she "is to be appointed by the Board of Governors on nomination by the alumni association and after consultation with the council [of senates]".

The Elections Committee believes that this provision and its implementation are inappropriate for a number of important reasons, and accordingly, we feel it appropriate that this issue be brought to the attention of both Vancouver and Okanagan Senates.

First, our university's convocation is significantly broader than the group represented by the Alumni Association - our convocation includes not only alumni, but faculty, librarians, senators, and most recently those honoured with emeritus status – all of whom have now been disenfranchised by the practice of having the Board appointed a chancellor upon the sole nomination of the Alumni Association (who previously did have a tradition of nominating a candidate, but this candidate was required to stand for election by the convocation).

Second, the history and tradition of our Chancellor's election runs deep and indeed dates back to the centenary we now are celebrating – I am informed that the first Chancellor election was in 1908, between Francis Carter-Cotton and Sir Charles Tupper. For the next 90 years or so, election turn-out was strong, averaging 20%, although the usual pattern was for a chancellor seeking re-election to stand unopposed, and for an election for new chancellor, it resulted in what was often an interesting contest.

In the past decade, thousands of people have voted with the size of our convocation doubling over the past 17 years, the percentage of those voting is of course low. In those years with low turnout, specifically the 1990s, it should be noted that the university significantly reduced the publicity around the election and its nomination process. Nevertheless, over the past three elections the number of votes cast for Chancellor has more than doubled. In our view, none of the above indicates the need for a replacement of a long-standing tradition without, at the very least, open discussion and review.

Third, the general practice throughout Canada is for the Chancellor to be elected - either from their convocations or by their senates; joint senates and board or by a joint council

of various sorts. Only one major institution, McGill, appoints its Chancellor by its Board alone. The British universities upon whom our structures are based also generally continue to elect their (vice) chancellors.

Finally, this provision was advanced by the government in the absence of consultation and communication with our Convocation, our Senates, and critically, our Council Elections Committee. Note that the Elections Committee's Terms of Reference state we "shall be responsible for recommending to the Council of Senates, in consultation with the Secretary to the Council of Senates, any rules necessary for nominations, elections, and voting in any election of the Chancellor."

In summary, our Committee is strongly opposed to this intended change - without consultation and careful consideration at the very least - and thus we are recommending the following resolution to both the Vancouver and Okanagan Senates for their consideration:

Whereas the office of Chancellor and its election is an institution dating back to the founding of UBC and our predecessor universities; and

Whereas the election of the Chancellor is an important symbol to many parts of the UBC community - including alumni, faculty, librarians, senators, and most recently those honoured with emeritus status - together forming our Convocation and coming together to select the ceremonial head of our University; and

Whereas the Chancellor is a member of university senates and serves in an academic role as conferrer of degrees and chair of the Convocation in addition to its ceremonial position; and

Whereas the autonomy of the University to govern its affairs should be respected and its internal governance should not be adjusted externally without thorough study, consultation, and consideration:

That this Senate resolve to express its concern for the lack of consultation with the University of British Columbia on the changes to the manner in which the Chancellor is selected;

And that this Senate further resolve to express its concern for the changing of an office elected by and from the Convocation to an office appointed by the Board of Governors;

And that this Senate further resolve to direct the Secretary of Senate to inform the Board of Governors, and the other senates currently under the University Act of the position of the Senate on this matter;

And that this Senate further resolve to direct the Chair of Senate to inform the Honourable Murray Coell, Minister of Advanced Education and Minister Responsible for Research and Technology, of the position of the Senate on this matter with the request that he communicate these concerns to others in the Government of British Columbia.

Re: Proposed Change in Budget Committee Membership

The Budget Committee has reviewed its operations and the operation of its Okanagan and Vancouver Sub-Committees over the past few years. It has become apparent that the original assumption of one UBC budget for which the Committee could advise the president is not the state of affairs that has developed, and that campus-specific budgets will be the norm. As the Sub-Committees for each campus are based on the full membership of the Committee from each campus, the current sub-committees are quite small.

The Committee therefore proposes increasing its membership so as to provide the sub-committees with more members and thus the ability to better advise the President and Academic Vice-Presidents on academic matters relating to the University Budget. We note that the size of the full committee will be large – 21 members – but note that a great majority of meetings are sub-committee meetings, and their more manageable memberships of between 10 and 12 people are in line with the previous Senate Budget Committee. For full meetings, 21 is not an unworkable number.

At present, the composition of the Committee is as follows:

- 44. The Budget Committee shall be composed of:
 - a. Three (3) Councillors, elected by and from the Council of Senates;
 - b. Four (4) members of the Okanagan Senate appointed by and from the Okanagan Senate, who must include at least two (2) faculty members and one (1) student; and
 - c. Four (4) members of the Vancouver Senate appointed by and from the Vancouver Senate, who must include at least two (2) faculty members and one (1) student.

The Committee proposes amending its compostion as follows (new text in **bold**, removed text struck through):

44. The Budget Committee shall be composed of:

- a. Three (3) Councillors, elected by and from the Council of Senates;
- b. Four (4) Nine (9) members of the Okanagan Senate appointed by and from the Okanagan Senate, who must include at least two (2) six (6) faculty members and one (1) two (2) students; and
- c. Four (4) Nine (9) members of the Vancouver Senate appointed by and from the Vancouver Senate, who must include at least two (2) six (6) faculty members and one (1) two (2) students.

The Committee therefore recommends:

That Senate endorse the changes in the Budget Committee membership specified for above. (NB: This item will be considered by the Council this June)

You may recall that in March 2007 the Senate approved a policy on the granting of emeritus status for retiring and retired faculty from UBC Okanagan and the former Okanagan University College. The full policy is at: http://www.senate.ubc.ca/okanagan/policies.cfm?ID=3 and the following excerpt is for your reference:

Criteria for Emeritus Status

Emeritus status is a recognition conferred upon individuals who have retired from UBC Okanagan but who are permitted to retain an honorary title. It is granted to those who meet the following criteria:

- Have a combined age at retirement plus years of full-time service to the University of 70 or more, and
- Have held a full-time Tenure, Tenure-track, Grant Tenure, or Grant Tenure-track position at the rank of Assistant, Associate, or Full Professor or Senior Instructor for a minimum of five years.

In meeting the above criteria, full account will be taken of previous faculty appointments at Okanagan University College or at UBC Vancouver.

Those individuals who held emeritus status at Okanagan University College on June 30, 2005 and who held a faculty appointment at OUC for a minimum of three years may apply to accept emeritus status at UBC Okanagan.

• Those individuals who retired from Okanagan University College between January 1, 2004 and June 30, 2005 and who held a faculty appointment in a degree program or librarian appointment at OUC for a minimum of three years may apply to accept emeritus status at UBC Okanagan.

The Policies and Procedures Committee is satisfied that Associate Professor Dr. Eggers of the Chemistry and Environmental Sciences Unit within the Faculty of Arts and Sciences meets the criteria as set out above and thus makes the recommendation that the Senate grant emeritus status to Dr. Nigel Eggers at the rank of Associate Professor Emeritus of Chemistry:

A brief survey of MATH 225 (Ordinary differential equations) students

indicated that there is a great deal of interest among UBC Okanagan students for applied courses. In addition, the two mathematical faculty who do research in mathematical biology are regularly sought out by mathematics students interested in summer research. An advanced course in mathematical biology will be of great benefit to these students, and will allow them to capitalize on their summer research investment. Also, the course might encourage students to double major in Mathematics and Biology.

Crimes against humanity and the evolution of the component crimes (including genocide, slavery, torture, sexual violence, apartheid) as legal concepts, social-historical phenomena, and sites of popular struggle. [3-0-0]

Proposed addition of new course on Crimes Against Humanity to PoliSci curriculum.

Rationale:

A recent addition to the Political Science course offerings is Poli 382, "Genocide: A Comprehensive Introduction." The present proposal is for an accompanying course to explore the related, but broader and analytically distinct, field of "Crimes Against Humanity," based on the definition of this term employed in the Rome Statute of the International Criminal Court (ICC).

Core legal concepts and frameworks will be deployed early in the course, and students will emerge with a deeper understanding of the basic legal instruments (international conventions, etc.) operative in this area. But rather than adopting a narrowly legalistic perspective, the course aims to introduce students to the broad sweep of crimes against humanity as historical-social phenomena, and

as sites of political mobilization and resistance. The intention is to provide students with a general grasp of the concept of crimes against humanity and its various subcomponents, from legal, historical, and social-movement perspectives.

The course is built around the following key themes/crimes: (1) Genocide and extermination; (2) Forced deportations and "ethnic cleansing"; (3) Slavery and human trafficking; (4) Arbitrary imprisonment; (5) Torture; (6) Forced disappearances; (7) Sexual violence; (8) Apartheid. This structure mirrors that of the instructor's forthcoming book, *Crimes Against Humanity: A Beginner's Guide*, which will serve as the main textbook for the course (along with a reading package of supplementary materials).

While the course is designed to complement Poli 382, it does not require students to have taken that course, and vice-versa.

The development of labs for both courses will provide students with direct experience in test administration and evaluation; these are marketable skills given the growing need for psychometricians. Offering of these two new courses at the 4th year level also allows the Department to provide much needed senior, advanced courses for our program.

Requirements of an Annotation of a Second or Subsequent Major or Honours Designation on a Baccalaureate Degree Previously Conferred

Students who have previously been granted a UBC Okanagan B.A. or B.Sc. may subsequently return and complete the requirements for an additional Major or Honours designation relevant to and within the same baccalaureate degree. The student will then be issued an updated parchment of the baccalaureate degree if the Honours program requirements have been fully met. The updated degree parchment will include an annotation specific to the Honours designation. The student will be required to surrender the degree parchment previously conferred upon the issuance of the updated parchment for the baccalaureate degree. The official transcript of the student will be updated to indicate that the requirements of a second Major have been met.

Returning students must receive the approval of the relevant Unit Head before the student may enter either the second Major or the Honours program. The Unit Head will ensure that the student's prior

ork is sufficiently current to progress within the proposed program of study.

Type of Action:

Allow upgrading of a Major to double Major or Honours degree for former Okanagan University College and UBC Okanagan Arts and Sciences graduates.

Rationale:

The proposal is general in that it allows students with a B.A. or B.Sc. in Arts and Sciences to upgrade their degrees to a double Major or to an Honours degree by meeting the program specific requirements.

Students who have completed a Majors degree in a discipline may wish to enhance their chances of being accepted into graduate studies. Many Canadian graduate schools show a decided preference for students who have completed an Honours degree [some make it a formal requirement] because such degrees provide evidence of research skills and experience, as well as a high level of academic performance. This option is intended to provide students who have already completed a 4-year degree from our institution [and its predecessor] the opportunity to meet the discipline requirements for an Honours B.A. and B.Sc. Similarly, students may increase their specialization by earning an additional Major by completing the program requirements.

Upgrading in this manner was permitted in the past for OUC students, who could "trade in" their Major degree for an Honours after they completed all to requirements of the Honours program.

There is currently no provision for upgrading an already granted degree at



UBC Okanagan, although the notion of allowing this appears to fit with the notion of life-long learning, as articulated in TREK 2010. We believe that we should be providing students with the opportunity to continue their education. This policy will allow them to have their increased proficiency formally recognized in the most straight-forward manner by having it reflected in their degree status

This provision is intended to apply only to the Faculty of Arts and Sciences. Other Faculties may consider adopting a similar policy but this is not intended to be university policy.

Rationale:

The proposed change of the program name to Gender and Women's Studies reflects the current state of this interdisciplinary field. Over the last decade, many Women's Studies programs in North America have altered their names to more accurately reflect the work that is being produced by the scholars who teach in and run them, and in feminist studies across the Humanities and Social Sciences. There has been a turn toward investigating "gender" as an analytical category rather than foregrounding "women" in isolation. While this will not substantially change the structure of the program at this juncture, it is an accurate reflection of the pedagogical orientation of the program and many other such programs, which holds that "women" and "femininity" cannot be properly understood without attention to ideas about "men" and "masculinity." In addition, the proposed new title reflects the importance of teaching in the program about transgender identities – which are not necessarily reflected in the category



"women" – and thus constitutes more inclusive language in regard to this marginalized population. Further, this is a strategically developing program, and its renaming will allow it to attract new faculty who are working on cutting-edge research in, for example, studies of masculinity, transgender identities, etc. Finally, when UBC Okanagan was created, UBC mandated this shift in the name of the program to include gender, perhaps to line up the program more squarely with the Centre for Women's and Gender Studies at UBC Vancouver. It must be noted that cultivating a relationship with the programs and scholars at Vancouver's Centre would be invaluable for our program.

Addressing a long-standing departmental concern that the BFA program in Visual



Art requires a studio theory course at the 200 level, this amalgamation of courses will reduce the number of credits required in the first year of the BFA (Visual Arts) from 36 to 30 while still retaining rigor in the program. The six credits removed from first year will be added to the second year in the form of a required Studio Theory course.

Theoretical discourse and critical thinking about creative arts practice have come to play a more significant role in the contemporary art world.

VISA 200 Studio Theory I and VISA 201 Studio Theory II are courses that will assist students in understanding critical issues in contemporary art, and in developing options for placing their own work in a contemporary art and theoretical context. The Department of Creative Studies is an interdisciplinary department with course offerings in Print-media, Painting,



Sculpture/Installation, Video, Photography, Drawing, Digital Media, Creative Writing, and Theatre/Performance Arts. In the latter stages of the degree program students may elect to concentrate on a specific discipline area, or, work across two or more disciplines. VISA 200 and VISA 201 will address the need of an internal department course dedicated toward establishing theoretical contexts for understanding complexities of meaning, production, and presentation in interdisciplinary art. Rationale:

This program will be among the first of its kind in the Canadian university system. Interdisciplinary programs have been developed in a number of European universities, particularly in the United Kingdom, to reflect current artistic practices that increasingly cross disciplinary boundaries.

The objective of the program is to provide students with a solid foundation in artistic practice and theory. The program will achieve this objective by training students in three disciplines: Creative Writing, Visual Arts, and Performance. It will offer extensive experience in interdisciplinary creation, combined with theoretical courses on theatre and world performance traditions, performance studies, theatre anthropology, and the history of devising. By learning to work collaboratively across the conventional boundaries that still separate the arts in most North American



university and conservatory programs, students graduating from the BFA with a major in Interdisciplinary Performance will be better prepared to meet the challenges of the contemporary art world.

The program's innovative curriculum will foster a process-oriented learning environment in which personal growth and collective work are interrelated; it will cherish tradition, support cultural diversity, and promote cross-disciplinary and cross-cultural connections; it will rely on the resources of the entire community to develop artistic projects that reflect the needs and aspirations of its contributors.

This B.F.A. will be relevant to young artists who are interested in all aspects of the performing arts: image, text, movement and sound. The training will prepare them for work as independent creative artists in the increasingly interdisciplinary and intercultural contemporary performance landscape. An example of the importance of this emergent territory is the creation of a new funding category (Inter Arts) at the Canada Council.

In keeping with the Trek 2010 Green Paper:

- This program will "recognize interdisciplinarity as a key principle in academic planning."
- The program's THTR courses will focus, in terms of knowledge delivery, on collective creation and collaborative learning models "developing innovative approaches that expose undergraduates to research-based and experiential learning."
- This creation based,



interdisciplinary program will strongly encourage students to "discover the value of pushing boundaries and taking risks in search of new knowledge and unconventional ideas."

Moreover, the program will fulfill UBC's commitment to training students to become "global citizens through interaction with their community and the world." Unlike more conventional theatre programs, the BFA in Creative Studies – Performance will familiarize students with a wide range of world performance traditions. Such traditions include the embodied transmission of cultural knowledge among Indigenous peoples.

A relationship between the BFA with a major in Interdisciplinary Performance and the En'owkin Centre is currently being explored. The En'owkin Centre offers a very successful interdisciplinary fine and performing arts program focusing on Indigenous cultural practices. The partnership we envision will provide a unique opportunity for aboriginal and non-aboriginal students to learn from one another and work collaboratively on interdisciplinary and intercultural projects.

The community outreach of the BFA with a major in Interdisciplinary Performance will provide students with the opportunity to research within communities and to create work and perform for those communities and the broader public.

The program's faculty members, who conduct creative and scholarly research internationally, are committed to developing global connections by bringing artists from different cultures and traditions to UBC Okanagan and by creating an international network of educational



exchange that will enable students to participate in interdisciplinary training programs, schools and institutes abroad.

<u>POLICY TITLE: Appointment of Designated Senior Academic Administrators (Joint Senate and Board Policy)</u>

1. Governing Principles

- 1.1. **Purpose:** This Policy is intended to:
 - 1.1.1. comply with section 27(2)(f) of the *University Act*, R.S.B.C. 1996 c. 468 and, with the approval of the UBC Okanagan Senate and the UBC Vancouver Senate, to establish procedures for the selection and recommendation of candidates for *Designated Senior Academic Administrators*.
- 1.2. **Method:** To succeed in this purpose this Policy:
 - 1.2.2. must be approved by the UBC Okanagan Senate, the UBC Vancouver Senate, and the Board of Governors, and not be amended without the same approvals; and
 - 1.2.3. will describe the creation of committees advising the President on recruitment and selection of *Designated Senior Academic Administrators* before the President makes a recommendation to the Board of Governors.
- **2.** <u>Definitions and Interpretation Rules:</u> A schedule to this Policy establishes the definitions of terms used in this Policy and any unique rules of interpretation that apply to this Policy.

3. Scope

3.1. General:

- **3.1.1.** This Policy applies to all appointments of *Designated Senior Academic Administrators*.
- **3.1.2.** The appointments of *Designated Senior Academic Administrators* are subject to the approval of the Board of Governors. The President shall provide advice and recommendations to the Board of Governors on the selection of *Designated Senior Academic Administrators*.
- **3.1.3.** *Advisory Committees* are to be established at the call of the President to consider candidates for an appointment as a *Designated Senior Academic Administrator* and to advise the President on recommendations to the Board of Governors.
- **3.2. Exclusions:** This Policy does not apply to appointments for positions other than *Designated Senior Academic Administrators*.

4. Advisory Committees

4.1. **President Convenes:** For the selection of candidates for *Designated Senior Academic Administrators*, the President shall convene an *Advisory Committee* to consider and advise the President on the candidates before the President makes a recommendation to the Board of Governors ("*Advisory Committee*").

5. Deputy Vice-Chancellors

5.1. Currently, the President of the University holds the title of Deputy Vice-Chancellor for UBC Vancouver and the Vice-President, Academic and Research (UBC Okanagan) holds the title of Deputy Vice-Chancellor for UBC Okanagan. If, at some point in the future, it is determined that the position of Deputy Vice-Chancellor is to be held by a person other than the President in the case of UBC Vancouver or the Vice-President, Academic and Research (UBC Okanagan) in the case of UBC Okanagan, the President will convene an *Advisory Committee* with the membership set out in the table below. However, unless and until such a determination is made, the normal selection process for the President or for the Vice-President, Academic and Research (UBC Okanagan), as applicable, will be used and the balance of this section 5 shall be of no effect.

- 8.2. **Student Member Elections:** For student members, the nominations and the elections are to be conducted in accordance with procedures satisfactory to the Registrar. The Registrar may authorize a student society to conduct the nominations and/or elections processes on his or her behalf.
- 8.3. **Senate Selections:** For Senators, the selection process is to be conducted in accordance with procedures satisfactory to the relevant Senate. Without limiting the generality of the foregoing, the Senate may authorize a committee (such as, for example, the Nominating Committee) to conduct the process or to simply nominate the Senators from that Senate.
- 8.4. **Council of Senates Selections:** For members selected by the Council of Senates, the selection process is to be conducted in accordance with procedures satisfactory to the Council of Senates. Without limiting the generality of the foregoing, the Council of Senates may authorize a committee to conduct the process or may simply nominate the faculty members.
- 8.5. **Appointment Term:** An *Academic Associate Vice-President* may be appointed for up to 6 years per term.

9. Replacement of Advisory Committee Members

- **9.1.** Vacancy or Inability to Participate: If a member of an *Advisory Committee* becomes unwilling or unable to serve as a member of the *Advisory Committee* before it has completed its work the President may appoint a replacement member in his/her discretion. While the replacement member may be any person whose participation is expected to contribute significantly to the *Advisory Committee's* activities, the usual practice is for the President to replace a member from a stakeholder group with a person from that group. If the President does not appoint a replacement member, the *Advisory Committee* may complete its work notwithstanding the vacancy.
- 9.2. **Student Status:** If a student member of an *Advisory Committee* ceases to be a student at the University but remains willing and able to continue to serve as a member of the *Advisory Committee*, the President may permit the student to continue to serve or may appoint a replacement student member at his or her discretion.
- 10. **Customary Practices:** In making appointments to an *Advisory Committee*, including replacement appointments under Section 9, the President will consider gender balance.
- 11. **Procedures Not to Conflict:** Provided that they are not in conflict with this Policy, the Procedures associated with this Policy may be created and amended in the same way as the Procedures associated with any other Policy passed by the Board of Governors.

Schedule to Policy # 18 Definitions and Other Interpretation Rules

1. Definitions

In Policy # 18 – Appointment of Designated Senior Academic Administrators (Joint Senate and Board Policy), the following terms have the meaning defined below, and shall have the same meaning in any Procedures associated with that Policy:

- a. "Advisory Committee" means an advisory committee to the President as defined in section 4.1.
- b. "Designated Senior Academic Administrators" means the following:
 - 1. Deputy Vice-Chancellors;
 - 2. Academic Vice Presidents;
 - 3. Vice President, Research; and
 - 4. Academic Associate Vice-Presidents.
- "Academic Vice Presidents" means the following:
 - 1. Provost and Vice President Academic (UBC Vancouver); and
 - 2. Vice President, Academic and Research (UBC Okanagan).
- d. "Academic Associate Vice-Presidents" means the individuals designated as such by the President, from time to time, in the Procedures associated with this Policy.
- e. "Responsible Executive" means:
 - 3. individual(s) assigned by the President, from time to time, to be responsible for this Policy and any associated Procedures; and
 - 4. any sub-delegate of that assigned responsible individual(s) except to the extent that the power to delegate is specifically excluded in this Policy or in the appointment by the President.
- f. "Deans" means the Deans of UBC Okanagan Faculties, the Deans of UBC Vancouver Faculties, and the Deans of Dual-Campus Faculties, as those units are described in resolutions passed by the Board of Governors on June 3, 2005.
- **g.** "Principals" means the Principal of the College of Health Disciplines and the Principal of the College for Interdisciplinary Studies.

PROCEDURES

- 1. Responsible Executive
 - 1.1. **Appointment**: The individual responsible for Policy #18 and these associated Procedures is the President.
 - 1.2. **Sub-Delegation:** The Responsible Executive is not limited in sub-delegation of the duties hereunder but remains responsible for oversight.
- 2. **Academic Associate Vice-Presidents:** The following individuals are designated as *Academic Associate Vice-Presidents*:
 - 2.1. Deputy Provost (UBC Vancouver);
 - 2.2. Vice Provost and Associate Vice-President, Academic Affairs (UBC Vancouver);
 - 2.3. Vice Provost and Associate Vice-President, Academic Resources (UBC Vancouver);
 - 2.4. Provost (UBC Okanagan); and
 - 2.5. Associate Vice President, Research.
- 3. **Remuneration:** The form and amount of remuneration of *Designated Senior Academic Administrators* must be established and documented in writing at or before the effective date of the appointment.

4. Administrative Leaves

4.1. As part of the terms of an appointment, a *Designated Senior Academic Administrator* may be granted an administrative leave, to be taken at the conclusion of the appointment, provided however that any such grant of

administrative leave as well as any remuneration and/or benefits to be received by the *Designated Senior Academic Administrator* during any such administrative leave must be documented in writing at or before the effective date of the appointment. Recognizing that administrative leave is intended to provide for a reasonable period of time for senior administrators who are returning the academic ranks to focus on their scholarly and professional activities and to re-integrate with their disciplines before they resume their regular duties as faculty members, administrative leave will only be granted to the *Designated Senior Academic Administrator* if he/she holds a tenured appointment and actually returns to active duty as a faculty member for at least one year immediately after the period of the administrative leave.

- 4.2. Time on administrative leave will not be included in years of service for the purpose of calculating study leave.
- 4.3. Any arrangements with respect to administrative leave for a *Designated Senior Academic Administrator* that that were established and documented in writing prior to May 1, 2008 will not be affected by these Procedures.
- 4.4. Any deviations from the provisions of these Procedures dealing with administrative leave may only be made with the written approval of the President.
